# FQHCs HAVE FOUR UNIQUE CHARACTERISTICS

Fees based on ability to pay (FQHCs must offer a sliding fee scale and individuals pay what they can afford)

Community governed and patient-centered to ensure they are responsive to their population (at least 51% of people serving on the governing board of an FQHC must be patients served by the FQHC)



# DID YOU KNOW? Community Health Centers are dedicated to improving access to quality, affordable primary health care

"Community Health Centers" FOHC refers to federally qualified health centers (FQHC) and FQHC Look-Alikes. They are non-profit organizations created by individuals in a community coming together with a mission to improve access to primary medical care in underserved areas. Every Community Health Center is different but they all care for patients in a community-oriented, culturally competent setting. And they contribute to the local economy by employing area residents and purchasing products and services. They are not operated by government entities.

## DID YOU KNOW? Community Health Centers are different from other primary care organizations

Community Health Centers FOHC have more federal standards and oversight placed on them than do other primary care providers. FQHCs must meet specific program requirements and offer core services to the people they serve. They must meet 19 specific program requirements set by the federal government that help promote the best care for their patients. These include a patient-majority board, specified hours of operation and staffing, mandated quality assurance and improvement programs, and public transparency of performance measures. FQHCs must demonstrate that they continue to meet these requirements to maintain their designation.

### DID YOU KNOW? Community Health Centers treat a wide variety of patients

You can see almost anyone in the waiting room of an FQHC. While 93% of patients have low incomes, the high-quality service also attracts many privately insured patients who could go elsewhere. FQHCs are required to treat anyone who seeks care regardless of insurance or ability to pay. Each FQHC must develop a sliding fee scale to help uninsured patients afford the care.

## DID YOU KNOW? Community Health Centers meet the highest standards of quality care

Community Health Centers FOHC not only provide a wide range of services in one location but they also do so with a mission mindset that sees all patients as equal and deserving of high quality care. Their outcomes are proven and they also have exceeded healthcare industry rates for attaining Patient-Centered Medical Home recognition and use of Electronic Health Records. FQHCs are leaders in performance transparency. The performance data for each and every FQHC in the country is posted online for public viewing.
