





RENEWED, AUTO-ENROLLED OR DISCONTINUED

- **Renewed** members retain same plan as 2016 (changes may have been made to plan details)
- Auto-enrolled members will be enrolled into a different 2017 plan (varies by county)
 - No action needed for these members. To retain coverage members will need to pay their 2017 monthly premium
 - Members can actively choose new plan for 2017
 - Effective dates follow open enrollment guidelines
 - o Some exceptions for Special Enrollment Periods (SEP) may apply
- **Discontinued** members will not be offered a 2017 plan (only certain counties)
 - These members need to enroll in a replacement plan by December 15, 2016 to ensure January 1 effective date and avoid a lapse in coverage.
 - May be eligible for a loss of minimum essential coverage SEP, however, we strongly encourage enrollment by December 15, 2016


